- Understand that once any of the image(s) referred to above have been published, TADWA has no control over subsequent use and disclosure of the images;
- Understand that TADWA does not guarantee that the image(s) will necessarily be used;
- Understand that I relinquish any rights to the image(s);
- Understand that I will receive no payment from TADWA for the use of my image(s); and
- Understand that I or my next of kin, where identified, can withdraw permission for the further use of my image at any time by written request to TADWA at the address below.
